#### Introduction

Myanmar, conducted criminal trial monitoring in Georgia, recommended criminal law reform in Vietnam, Georgia and Ukraine and trained CSO and justice sector professionals in Croatia, Cambodia, Ukraine, Russia, Moldova, Armenia and other former Soviet countries. He has authored or contributed to several training and advocacy tools on topics such as violence against women, wartime sexual violence, sanctions, linkage evidence and human rights investigations. Alexandre has also lectured law at the Royal University of Law and Economics in Cambodia and served as Adjunct Professor in International Criminal Law at the University of Washington and Lee in the USA.
